Trauma Nursing Core Course – Provider Re-verification

The TNCC-P Reverification Course is designed to re-verify core-level trauma knowledge and psychomotor skills associated with the delivery of professional nursing care to the trauma patient for the Registered Nurse desiring re-verification. This content is presented through lectures and psychomotor skill stations.

Participants must have a current TNCC-P card to participate in this course. If the participant's TNCC-P status is expired, they must attend a full TNCC Provider Course. The participant **MUST THOROUGHLY READ THE TNCC-P MANUAL BEFORE THE COURSE.** A pre-test will be assigned with your manual to assist in your preparation for this course.

The Emergency Nurses Association will issue a card verifying the successful completion of the TNCC-P. RN participants will receive 6.5 CECH's for attendance regardless of performance.
